## RAFFLE PROMOTION TERMS & CONDITIONS

### INTRODUCTION

StockMVP Limited is a limited liability company incorporated under the laws of the Republic of Cyprus with registration number HE 440681 and having its registered address at 10 Ioanni Kapodistria, 3032 Limassol, Cyprus (the "**Company**"). The Company is offering its Clients the opportunity to participate in the Raffle Promotion (the "**Promotion**"), as specified in the Terms and Conditions (the "**T&Cs**") below. ### TERMS AND CONDITIONS

1. The Promotion starts the time the Company notifies the Client that the Promotion is effective and terminates when the Company notifies the Client that the Promotion is terminated, via a notification through the Company's website and/or mobile app and/or any of the communication channels that the Client provided to the Company during account opening.
2. The Promotion is available to Clients who subscribe to the Company's Services either via a monthly or annual subscription plan:
  - **Monthly subscription** - The Client will be given one (1) raffle for each month of subscription. For example, in the first month of a subscription the Client will have one (1) raffle, in the third month of an ongoing subscription the client will have three (3) raffles, in the eleventh month of an ongoing subscription the Client will have eleven (11) raffles and so on.
  - **Annual subscription** - The Client will be given fifteen (15) raffles, one (1) raffle for each of the twelve (12) months of the annual subscription plus three (3) bonus raffles.
3. Prices will be awarded each month to three (3) Clients after an online draw which will determine the three (3) winning raffles for the month. The Clients will enter each month's draw with the available number of raffles they have. If a Client wins the first prize in a month's draw, that Client's number of raffles will be divided by two (2) for the remaining draws of that year. For example, if the Client has six (6) raffles and wins the first prize, for the next month's draw he will have three (3) raffles.

4. The Promotion runs from the 1<sup>st</sup> of January to the 31<sup>st</sup> of December of each year. After a year's end, all raffles that Clients have accumulated during the year will be cancelled and the Clients will start gaining raffles again in the new year according to their monthly or annual subscription plan.
5. Prices are awarded after each month's draw for the first, second and third place. The prices for each place can be viewed in the Company's website and mobile app. The Company reserves the right, at its absolute discretion, to change the available prices at any time without prior notice to the Client, by posting the new prices in the relevant section of the Company's website and mobile app.
6. If the Client fails to provide correct contact details and/or residential address in order for the prices to be delivered to them, then they will lose their right to the price and the price will be awarded to the Client who has the immediately next winning raffle.
7. For physical prices that have to be couriered and/or mailed to the Client, the Company reserves the right to pay the equivalent amount of the price in cash rather than couriering/mailing the price, in cases where the Company in its absolute discretion considers that courier/mail is unavailable and/or not commercially viable to the Client's residential address. The Company has absolute discretion to decide what is the fair equivalent cash amount for a physical price and it will not accept any disputes and/or requests for negotiating such decision.
8. Clients will automatically be eligible to participate in the Promotion after successfully opening an account with the Company and subscribing to the Company's Services. Clients may opt-out from the Promotion at any time by contacting the Company at [support@stock-mvp.com](mailto:support@stock-mvp.com).
9. The Client agrees that by entering this Promotion they consent to the Company processing any personal data which they provide while opening an account and/or participating in the Promotion. The personal data is collected and processed only to the extent which is necessary to administer and run the Promotion and the Company will not disclose any data about Clients, except to the extent stipulated in these T&Cs and/or any other legal document available in the Company's website and/or mobile app. Each Client has the right to withdraw their consent for the processing of their personal data at any time, but such withdrawal may result in the disruption, suspension or termination of the Client's participation in the Promotion. The Client acknowledges and agrees that in case they win a price, they consent to the Company publishing their name and username in the Company's website, mobile app and/or other social media and communication channels specifying them as the winners for that month's draw.
10. The Company may request additional documentation from the Client before or during their participation in the Promotion and the Client is obliged to provide the requested documentation. Failure to do so, may result in the disruption, suspension or termination of the Client's participation in the Promotion.
11. The Company's employees, affiliates, service providers, associates and/or their family members are not eligible to participate in this Promotion.

12. This Promotion cannot be combined with any other bonus and/or promotions offered by the Company.
13. Failure to abide by any provision of these T&Cs, or any other legal documents available in the Company's website and mobile app which are incorporated herein by reference (including without limitation the Company's Terms of Service and Privacy Policy), may result in immediate disqualification from the Promotion. Disqualified Clients will lose their right to participate in the Promotion and the prices offered.
14. The Company reserves the right, at its absolute discretion, to cancel the Promotion at any time without prior notice, to reject offering the Promotion to any Client and/or to disqualify any Client, if it determines, at its absolute discretion, that such action is reasonable and/or necessary.
15. The Company reserves the right to change these T&Cs at any time without prior notice. In the event that any changes are made, the revised T&Cs shall be posted on the Company's website and mobile app. It is advisable to regularly consult the latest information posted on the Company's website and mobile app to remain updated in case of any changes.
